Autism Rate increases to 1 in 50 Children

The federal government is increasing the incidence of autism indicating that the developmental disorder affects 1 in 50 children. The latest estimate released March, 2013 by the U.S. Centers for Disease Control and Prevention (CDC) is based on data from a national telephone survey of nearly 100,000 parents conducted in 2011 and 2012.

In the survey, parents were asked several questions about their children

including whether their child had an autism spectrum disorder. The results indicate that autism is occurring in 2 percent of school-age children.

Just last year in March 2012, the CDC released numbers showing that the autism rate was at 1 in 88 American children. The earlier data came from the study of health and education records collected on 8 year-olds. This new estimate includes children ages 6-17 and because it is

parent reported it may be considered less reliable.

Federal officials say the increase is largely due to better diagnosis of autism spectrum disorders in older children and in minority populations that have gone previously undiagnosed. As with earlier studies boys are four times more likely to have the disorder than girls.



Finding the Artist in all of Us: Art Classes at DHI a Great Success

Since February on alternating Tuesdays, Social Worker and Artist Melissa Lima leads art classes for our clients and the community at the Development Homes Office. Each week Melissa chooses a theme and a medium of art for the aspiring artists to explore their creativity. The classes are so successful that often more than 40 people attend the sessions.

The classes recognize the

artistic nature in all of us and nurture the belief that art can bridge the gap between persons with disabilities and persons without disabilities. Persons with disabilities may not have had the opportunity to explore their creativity or express themselves artistically. These classes tap into that unexplored nature. The art classes are designed with persons with disabilities in mind but are open to the

entire community. In this way, the classes create vibrant connections in the community through the arts.

To make the art classes even more exciting, the classes received a grant from the City of Grand Forks through the North Valley Arts Council to invite guest professional artists to the classes to experiment with new mediums. The grant will

help DHI pay the artists for their instruction and for the art supplies.

There will be many opportunities for our artists to show off their work throughout the year.

In January 2013, Tommy Mikkelson, 21 a Grand Forks Native and Development Homes ACEs employee represented Team USA Special Olympics at PyeongChang, South Korea in Alpine Skiing Events taking home the Gold medal in the Alpine Novice Super G, the Bronze Medal in the Alpine Novice Slalom and 8th place in the Alpine Ski Novice Giant Slalom. Before traveling to South Korea, he participated in a 5-day training camp, traveling to Lake Placid, NY. There, his team prepared for their long trip and trained in skiing.

Tommy has a lifelong love of sports and began participating in Special Olympics Grand Forks at age 12. He participates in sports year round, including soccer, basketball, bowling, swimming, track and field, along with the winter sport of skiing. In 2010 he represented Special Olympics-North Dakota on the basketball team that went to Special Olympics National Competition in Lincoln, NE.

Upon his return from the PyeongChang Competition, he represented Special Olympics throughout Grand Forks, Speaking about SPREAD THE WORD TO END THE WORD at several local schools. He spoke at RRHS, CHS, South Middle school, West Elementary, along with representing the movement on the local radio station. He delivered a speech which explained why using the "R" word in everyday speech is painful and should be stopped. Many students took the pledge to end the "R" word.

North Dakota Senator Heidi Heitkamp presented Tommy with an American Flag that she had had flown over the Capitol in his honor while competing. Congratulations Tommy!

A Word from our CEO

On February 11th, Development Homes sponsored a premiere showing of the new documentary called “I am a Person” at the Empire Arts Theater. “I am a Person” was produced by Prairie Public TV, in conjunction with the North Dakota Association of Community Providers. It tells about the real lives of people with developmental and intellectual disabilities in North Dakota, in their own words. The stories are compelling and profound. They go a long ways towards dispelling myths that are commonly held about people with disabilities.

There are stories that need to be told. They are stories of ordinary and extraordinary lives, stories of resilience and unimaginable fortitude. They are stories of nightmares and dreams. The horrors of what we have done to an entire segment of our society will astound and humble the observer. And they are stories of those who created and nurtured the opportunities for dreams to be realized. They are stories of liberation.

In 1980, a class action lawsuit was initiated by a group of parents on behalf of people with intellectual disabilities in North Dakota, ARC v. ND. At the time, North Dakota had more people institutionalized per capita than any other state in the country, and spent the least on their care. Monumental changes in the service delivery system in the state have resulted in a service delivery system that is truly exemplary.

Development Homes stepped up to the plate and grew from one children’s group home, developed in 1974, to its current array of 7 group homes housing 45 people, around 80 people supported in their own apartments, a family support program, and an employment and community services day support program that largely focuses on providing real, minimum wage or better employment for people with disabilities.

It has been exciting for DHI’s board and staff to be at the forefront of quality services for almost 40 years. We truly appreciate our many partners in the community who have helped to enhance the lives of those who have been disenfranchised by society. You help to create and sustain an abundant quality of life that is demonstrated every day in the lives of some very remarkable people.
